- ◆ Nicola is the author of two legal thrillers, including “Until Proven Innocent”, which was in March 2023

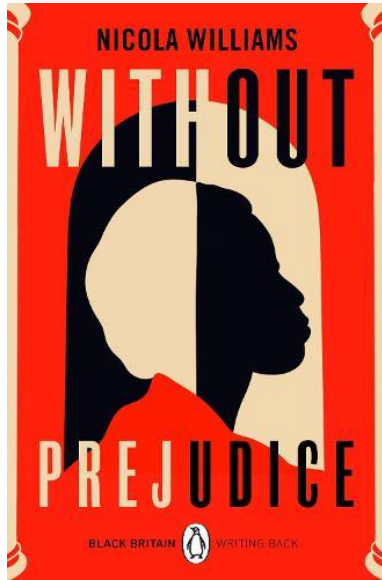

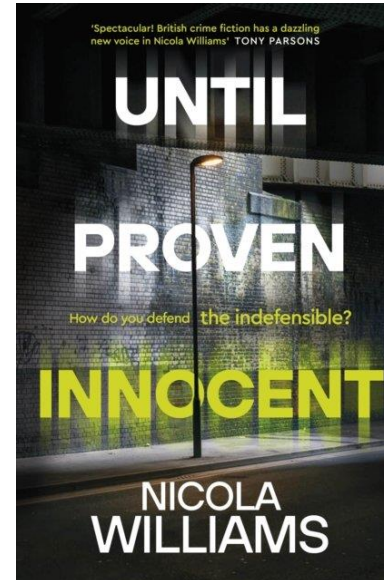

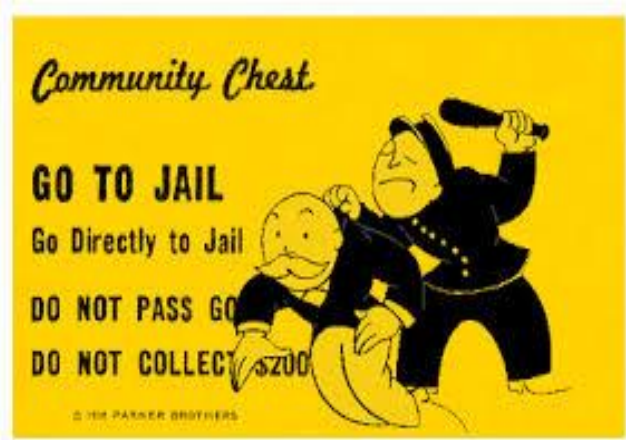
