SIGNIFICANT LEGISLATION TO DATE

UK Acts of Parliament on Energy

Name of Act	Session	Date of Royal Assent	Brief Summary of the Act
Atomic Energy	1988/89	25/05/1989	The Act altered the financial limit imposed by section 2(1) of the Nuclear Industry (Finance) Act 1977 in relation to British Nuclear Fuels plc. It also made provision with respect to the recovery of certain expenses by the Health and Safety Executive; amended sections 18 and 19 of the Nuclear Installations Act 1965; and made provision in connection with the Convention on Assistance in the case of a Nuclear Accident or Radiological Emergency.
Electricity	1988/89	27/07/1989	The Act made provision: for the appointment and functions of a Director General of Electricity Supply and of consumers' committees for the electricity supply industry; with respect to the supply of electricity through electric lines and the generation and transmission of electricity for such supply; to abolish the Electricity Consumers' Council and the Consultative Councils established under the Electricity Act 1947; for the vesting of the property, rights and liabilities of the Electricity Boards and the Electricity Council in companies nominated by the Secretary of State and the subsequent dissolution of those Boards and that Council; for the giving of financial assistance in connection with the storage and reprocessing of nuclear fuel, the treatment, storage and disposal of radioactive waste and the decommissioning of nuclear installations; to amend the Rights of Entry (Gas and Electricity Boards) Act 1954 and the Local Government (Scotland) Act 1973.
Coal Industry	1989/90	19/03/1990	The Act made provision with respect to grants made by the Secretary of State to the British Coal Corporation and further provision with respect to grants and loans under existing powers; regarding the licensing of coal working, searching and boring and the preservation of amenity in connection with opencast coal working.
Coal Mining Subsistence	1990/91	25/07/1991	The Act included provisions for imposing obligations on the British Coal Corporation, including obligations corresponding to those voluntarily accepted by them under their code of practice concerning compensation for subsidence damages.
Coal Industry	1991/92	06/03/1992	The Act made provision for extending the duration of, and increasing the limit on, grants under section 3 of the Coal Industry Act 1987 and to repeal the Coal Mines Regulation Act 1908.
Gas (Exempt Supplies)	1992/93	19/01/1993	The Act amended section 5 of the Gas Act 1986. It included provisions for: the prohibition on unauthorised supply: exemptions from prohibition on unauthorised supply; and keeping of the register.
British Coal and British Rail (Transfer proposals)	1992/93	19/01/1993	The Act conferred powers on the British Coal Corporation and the British Railways Board to act in relation to proposals for the transfer of any of their functions, property, rights or liabilities to any other body or person.

Energy	2007/08	26/11/2008	The Act included provisions relating to gas importation and storage; in relation to electricity generated from renewable sources; about payments to small-scale generators of low-carbon electricity; about the decommissioning of energy installations and wells; about the management and disposal of waste produced during the operation of nuclear installations; relating to petroleum licences; about third party access to oil and gas infrastructure and modifications of pipelines; about the duties of the Gas and Electricity Markets Authority; relating to gas meters and electricity meters and provision relating to electricity safety; to make provision about the security of equipment, software and information relating to nuclear matters.

The Act defined the term "green energy". Contained provisions to promote its development, installation and usage.

Energy	2009/10	08/04/2010	The Act made provisions relating to the demonstration, assessment and use of carbon capture and storage technology; about reports on decarbonisation of electricity generation and development and use of carbon capture and storage technology; requiring benefits to be provided by holders of gas or electricity supply licences; on the functions of the Gas and Electricity Markets Authority; about general duties of the Secretary of State in relation to gas and electricity markets; about electricity generation licences; and about persons authorised to supply gas or electricity.
Energy	2010/12	18/10/2011	Included provisions for the arrangement and financing of energy efficiency improvements to be made to properties by owners and occupiers; about the promotion by energy companies of reductions in carbon emissions and home-heating costs; for increasing the security of energy supplies; about access to upstream petroleum infrastructure and downstream gas processing facilities; about a special administration regime for energy supply companies; about licence modifications relating to offshore transmission and distribution of electricity; about the security of nuclear construction sites; about the decommissioning of nuclear sites and offshore infrastructure; for the use of pipelines for carbon capture and storage; for an annual report on contribution to carbon emissions reduction targets; for action relating to the energy efficiency of residential accommodation in England; for the generation of electricity from renewable sources; about renewable heat incentives in Northern Ireland; about the powers of the Coal Authority.
