
What is hostile profiling ?

Why now ...?



Because the world of work is undergoing fundamental change, challenging our existing models of working and surfacing new threats and risks.

Because Covid-19 has demonstrated our limited ability to foresee major events with significant consequences - because we just don't believe they could happen.

Because criminals are exploiting all the above to launch attacks, hoodwinking people into exposing "things of value".


EARLY EFFORT IS NEEDED NOW TO FUTUREPROOF YOUR BUSINESS AND REVIEW ATTITUDES, RISKS AND PROCEDURES

What benefit will we get from hostile profiling ?

- You will see what the criminals see.
- This is a Service rather than a product and is bespoke to you.
- The Service is only limited by time and imagination.
- Acting on what the profile finds increases your resilience
- It is completely passive and undetectable.
- It is Legal.
- It is Due Diligence and good Governance.
- You could deploy it throughout your Supply Chain.
- When you know your risks, you can minimise them.



Insider Threat Challenge The Problem



22% of data breaches are caused by Insiders 57% of data breaches are caused by External Threats 21% of data breaches are caused by non-malicious errors Businesses can expect to conduct between 1 & 5 fraud investigations per year [Chartered Institute of Internal Auditors]



Who Is the Average Insider ?

- A loyal employee for 5 years before they become an Insider
- Insiders are typically detected <u>after</u> 33 months of committing fraud
- 51% of Insiders are managers or above [Carnegie Mellon]
- 88% are permanent staff rather than contractors [CPNI]
- 7% join a company to <u>deliberately</u> cause an Insider act
- 89% of Insiders have no previous criminal record
- Many Insiders emerge from disaffected clusters of staff often caused by a 'toxic' manager
