Summary Of Entrust Survey Results

91% of employees are in favour of a hybrid work environment but cite challenges to security and productivity.

Leaders cited the security of home internet connections, leaked sensitive company information and cyberattacks from bad actors as their top security concerns — all of which are closely tied to data remaining secure outside the office and potential challenges to the hybrid work model.

Entrust Hybrid Workplace Research Summary

Hybrid To Stay But Security & Productivity Concerns High

- ▶ 80% of company leaders said they are currently using or considering a hybrid workplace
- ▶ 54% of employees reported up to 6 instances of lost productivity due to network access issues
- ▶ 21% of leaders cite leakage of sensitive company data among top security challenges

Home Offices' Require Added Security Measures

- ▶ Broad MFA adoption - cited by 70% of respondents
- ▶ Passwordless preferred MFA option at 76% using biometrics and mobile push authentication
- ▶ Training gap - 81% of business leaders say they have offered employees home office data security training, but only 61% of employees said their company offers such training
