## UKRAINIAN WEEK IN LONDON - OCTOBER 8-14, 2018 A FULL WEEK OF ACTIVITIES TO PRESENT TODAY'S UKRAINE TO THE U.K.

The British Ukrainian Chamber of Commerce (BUCC) is holding Ukrainian Week in London ("Ukrainian Week") on October 8-14 2018, organised with the Council of British Chambers of Commerce in Europe (COBCOE), the National Investment Council of Ukraine, the Atlantic Council (U.S.), the European Bank for Reconstruction and Development (EBRD), the Royal United Services Institute (RUSI) and other leading U.K. and Ukrainian institutions. Its lead sponsors are the industrialist Yuriy Kosyuk, the founder of MHP, Ukraine's largest agro-industrial holding and SoftServe, Ukraine's leading IT software developer.

Ukrainian Week is to be held at a number of prestigious venues in central London. It consists of the following seven days of events addressing Security Issues, Trade and Business, including covering Agriculture, Finance and Investment, Tourism, and IT and Technological Innovation, as well as Arts, Design and Fashion, with an emphasis on how Ukraine can build partnerships with Britain and British firms in all of these sectors.

**DAY 1, ON OCTOBER 8TH**, at the Royal United Services Institute ("RUSI") focuses on strategic challenges, threats, and opportunities for cooperation between Ukraine and the U.K. and is organized with the Atlantic Council and RUSI.

**DAY 2, ON OCTOBER 9TH**, at the Savoy Hotel, focuses on Bilateral Trade, Agriculture, Tourism and Regional Development. It involves a Ukrainian government-led Trade Mission to the U.K., including B2B meetings.

**DAY 3, ON OCTOBER 10TH**, at the EBRD, focuses on Investment and Finance in Ukraine as well as Infrastructure, Oil and Gas and Renewable Energy.

**DAY 4, ON OCTOBER 11TH**, at the EBRD, will cover Ukrainian IT and Technological Innovation and will showcase leading Ukrainian tech companies. A wide variety UK startups and scale-ups will be attending looking for Ukrainian IT partners. There will also be a parallel program on Law, Accounting and Doing Business in Ukraine.

DAY 5, 6 AND 7, ON OCTOBER 12-14, events will be held to present Ukrainian arts, design and fashion, including by holding an exhibition of Ukrainian art.

We are involving the participation of leading U.K. and Ukrainian political and government leaders, analysts, business executives, investors and innovators, as well as leaders in the creative arts, design and fashion. Ukrainian Week will attract a high level audience in all of the sectors covered. With each day of Ukrainian Week audiences targeted whose interests are focused on the proposed subject matter.

Partnerships with the Financial Times (as a media partner, including for a Supplement on Ukraine to be published globally, both in print and online, in the FT around mid-September) and the involvement of Weber Shandwick for public relations will ensure wide publicity for the event.

During Ukrainian Week, there will also be a number of other events, receptions and dinners, such as high level dinners organised by the BUCC for key Ukrainian government officials with UK business leaders. As the Ukrainian Week program indicates, it will be the largest event ever held on Ukraine anywhere. It will attract attention to the progress that Ukraine and Ukrainian businesses have made.

Ukrainian Week is intended to spur much greater interest by U.K. and other western banks, investment funds and companies in Ukraine to encourage them to finance business in, and trade with, Ukraine, by providing an informed picture of Ukraine. We aim to correct the many misleading or outdated images of Ukraine that persist with many in the U.K.

In the context of Ukrainian Week, there will also be discussion on how after Brexit, the U.K., as one of the world's largest net importers of food, can significantly enhance its prosperity and food security through new trade relations with Ukraine, one of the world's largest net food exporters. The UK's access to Ukraine's food exports has been generally blocked under the existing EU-Ukraine Trade Agreement (the "DCFTA"), effectively protecting the EU's high cost base farmers, to the detriment of U.K. consumers. Ukrainian Week should establish a convincing case for why a new U.K.-Ukraine free trade agreement covering food and other key sectors can result in important post-Brexit trade benefits for the U.K. and its consumers, including for UK meat and dairy farmers that constitute two thirds of British agriculture and that need cheaper feed. As the UK imports over half of its food, this can be of critical benefit for the UK and its economy. These potential benefits from Ukrainian trade are not generally understood in the UK. Ukrainian Week should begin the process of developing close UK-Ukraine trade relations.
